Q: How can we improve the turnoff into the club from Highway 28

A: MTO required KN hire a consultant to analyze the traffic from both directions; and it was considered safe. We may consider widening the driveway as part of our capital plans.

Q: Please explain membership A class and B class; and the discrepancy in the AGM notice that calls for members at age 16 who cannot vote

A: Class B was added last year as a special case that had to do with ski racing where one could be a member but non-voting; one would buy a membership without trail privileges; it has not been taken up at this point. There may be a discrepancy in the AGM notice.

Q: You talked about the challenge of membership for this year. Are there any initiatives on how to get new members?

A: we budgeted by reducing our forecast of membership and increasing the numbers for daily passes. We also are incentivising by making memberships more attractive (value for money). We are also planning more events for volunteers
